DATA PROTECTION DECLARATION FOR THE ATTENTION OF PERSONS APPLYING FOR AN EMPLOYMENT OPPORTUNITY WITH COMADUR SA

1. What does it involve?

This is the data protection declaration addressed to persons applying for an employment opportunity with COMADUR SA, Col-des-Roches 33, CH-2400 Le Locle, (hereinafter the "employer"). The employer is responsible for data processing within the meaning of this data protection declaration.

2. What type of personal data do we process?

We obtain personal data that we collect or receive during the recruitment, hiring and selection phase of new employees (i) from you, (ii) from placement/recruitment agencies, (iii) from third parties, (iv) from private or public institutions and (v) from other public resources. Such personal data mainly collected in a document called a CV or application file includes:

- your contact details;
- your marital status, family situation;
- details of your qualifications, such as your skills, experience and professional background;
- work certificates;
- all data that we are required to collect, process and transmit under applicable laws and regulations.

3. For what purposes may we process your personal data?

We process your personal data for the following purposes:

4. To whom may we disclose and transfer your personal data?

We share your personal data with the following recipients or categories of recipients, so that they can use the data in their own name and under their own control or act on our behalf and/or as partners, but only for the purpose of fulfilling their obligations; in which case they are contractually bound to observe an appropriate level of data protection when processing your personal data:

- our parent company, The Swatch Group Ltd, Faubourg du Lac 6, 2501 Biel/Bienne, Switzerland (hereinafter the "Swatch Group") and its affiliates;
- public or private bodies to which we disclose your personal data under legal obligations, such as social security institutions, unemployment offices, etc.;

In the absence of an adequate level of data protection in the intended country, we ensure adequate protection of your personal data by requiring recipients to comply with binding contractual obligations in accordance with applicable standards approved by the competent supervisory authorities or by relying on other guarantees, such as self-certifications, approved by the competent supervisory authorities.
